¹ SFDR is an EU regulation that aims to help investors by providing more transparency on the degree to which financial products have environmental and/or social characteristics, invest in sustainable investments or have sustainable objectives. SFDR aims to help investors to choose between products by classifying funds into three distinct categories, according to the degree to which sustainability is a consideration. These categories align to Articles 6, 8 and 9 within the EU SFDR and are summarised below:

- **Article 6** funds either integrate environmental, social and governance (ESG) considerations into the investment decision making process, or explain why sustainability risk is not relevant, but do not meet the additional criteria of Article 8 or Article 9 funds.
- **▲ Article 8 or Light Green** funds promote social and/or environmental characteristics and may invest in sustainable investments, but do not have sustainable investing as a core objective.
- **▲ Article 9 or Dark Green** funds have a sustainable investment objective.
